**A BILL**

To require the Bureau of the Census to collect information on deafblind individuals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4 (a) SHORT TITLE.—This Act may be cited as the  
5 “Deafblind Disabled Americans Table Approximation  
6 Act” or the “Deafblind DATA Act”.

7 (b) FINDINGS.—Congress finds the following:

8 (1) Individuals who are deafblind experience  
9 concomitant hearing and vision loss that may pre-

1 vent access to information, cause severe communica-  
2 tion challenges, and interfere with social and emo-  
3 tional well-being. In children, deafblindness may im-  
4 pact development and educational attainment, while  
5 in adults, deafblindness may interfere with employ-  
6 ment and other areas. The National Center on  
7 Deafblindness estimates 10,000 children and 40,000  
8 adults are deafblind, the National Association of  
9 Regulatory Utility Commissioners estimates 70,000-  
10 100,000 people are deafblind, and the Helen Keller  
11 National Center for Deafblind Youths and Adults es-  
12 timates 2.47 million Americans have combined hear-  
13 ing and vision loss.

14 (2) It is difficult to determine the precise num-  
15 ber of individuals who experience combined hearing  
16 and vision loss, and estimates from various national  
17 counts offer radically different estimates.

18 (3) An accurate, centralized count of all individ-  
19 uals who are deafblind in the United States is nec-  
20 essary to effectively serve the unique needs of this  
21 population. Without a comprehensive national pic-  
22 ture of this population, individuals who are deafblind  
23 may not receive the supports necessary to access in-  
24 formation, communicate effectively, and better their  
25 social and emotional well-being.

1           (4) The Bureau of the Census currently does  
2           not count individuals who experience combined hear-  
3           ing and vision loss. Through the American Commu-  
4           nity Survey, the Bureau does collect data on those  
5           who are deaf or have “serious difficulty hearing”  
6           and those who are blind or have “serious difficulty  
7           seeing even when wearing glasses”. However, this  
8           data is not cross referenced to provide information  
9           about those who have both limitations.

10           (5) Some people who experience combined hear-  
11           ing and vision loss identify as deafblind or as a part  
12           of the deafblind community.

13           (6) By cross referencing this existing data to  
14           establish a count of all respondents to the American  
15           Community Survey who experience concomitant  
16           hearing and vision loss, an estimate of the United  
17           States deafblind population may be calculated.

18 **SEC. 2. REPORT AND PUBLICATION ON DEAFBLIND INDI-**  
19 **VIDUALS.**

20           (a) REPORT.—Not later than 180 days after the date  
21           of the enactment of this Act, the Director of the Bureau  
22           of the Census shall submit to Congress a report on the  
23           feasibility of publishing the table described in subsection  
24           (b) and the feasibility of expanding data collection on indi-  
25           viduals who experience combined hearing and vision loss

1 in the American Community Survey (or any successor sur-  
2 vey).

3 (b) PUBLICATION OF TABLE.—

4 (1) IN GENERAL.—Beginning in 2026 and each  
5 year thereafter, the Director of the Bureau of the  
6 Census shall publish, on the public website of the  
7 Bureau, a table summarizing respondents to the  
8 American Community Survey (or any successor sur-  
9 vey) who answered “Yes” in such Survey to being  
10 both deaf and blind. The table shall include the fol-  
11 lowing information, sorted by the State in which  
12 such respondent resides:

13 (A) The sex, race, and age of any such re-  
14 spondent.

15 (B) Economic characteristics of any such  
16 respondent, including employment status, edu-  
17 cational attainment, earnings, and poverty sta-  
18 tus.

19 (2) LIMITATION.—The Director shall ensure  
20 that no personally identifiable information of any in-  
21 dividual is published under paragraph (1).
